COUNTY MANAGER'S RECOMMENDATION OR COMMENTS: Recommend Approval

SUMMARY OF INFORMATION:

Effective July 1, 2016, Forsyth County and the City of Winston-Salem consolidated the operations of the Forsyth County Sheriff's Office Crime Scene Investigations Unit with the Winston-Salem Police Department's Forensic Services Section. As a result, items associated with the former Crime Scene Investigations Unit are no longer needed and are being surplused to be sold to interested neighboring governmental entities for use by their law enforcement agencies. The personal property being declared surplus by Forsyth County and recommended to be sold to Davie County is identified in attached "Exhibit A". The attached Resolution authorizes the sale of the identified surplus County personal property to Davie County for \$27,000 for use by its Sheriff's Office.

The attached Amendment to the 2016 Motive Equipment Replacement Capital Projects Ordinance appropriates the \$27,000 in sale proceeds to the Sheriff's budget for emergency vehicle expenses.

**RESOLUTION DECLARING CERTAIN PERSONAL PROPERTY SURPLUS AND
AUTHORIZING ITS SALE TO DAVIE COUNTY FOR USE BY ITS SHERIFF'S
OFFICE PURSUANT TO THE PROVISIONS OF N.C.G.S. 160A-274
(FORSYTH COUNTY SHERIFF'S OFFICE)**

WHEREAS, effective July 1, 2016, Forsyth County and the City of Winston-Salem have consolidated the operations of the Sheriff's Crime Scene Investigations Unit with the Winston-Salem Police Department's Forensic Services Section to form the City/County Forensic Services Program under the management of the Winston-Salem Police Department; and

WHEREAS, N.C.G.S. 160A-274 authorizes any governmental unit to sell any interest in personal property to any other governmental unit upon such terms and conditions as it deems wise, with or without consideration; and

WHEREAS, the Forsyth County Sheriff recommends that Forsyth County sell the personal property identified on the attached list entitled, "Exhibit A-Decommissioned Crime Scene Investigations Equipment", to Davie County for \$27,000 for use by its Sheriff's Office for law enforcement purposes.

NOW, THEREFORE, BE IT RESOLVED by the Forsyth County Board of Commissioners that the County personal property identified on the attached list entitled, "Decommissioned Crime Scene Investigations Equipment," which is incorporated herein, is hereby declared surplus to the needs of Forsyth County.

BE IT FURTHER RESOLVED that the Forsyth County Board of Commissioners hereby authorizes the sale of the said surplus County personal property identified herein to Davie County for \$27,000, pursuant to the provisions of N.C.G.S. 160A-274, for use by its Sheriff's Office to conduct crime scene and forensic operations, on the condition that Davie County agrees that neither Forsyth County nor the Forsyth County Sheriff's Office will be held liable or responsible for any failure in performance of the said equipment.

BE IT FURTHER RESOLVED that the Chairman or County Manager and Clerk to the Board are hereby authorized to execute necessary documents, on behalf of Forsyth County, to convey the said surplus County personal property to Davie County for use by the Davie County Sheriff's Office, subject to a pre-audit certificate thereon by the Forsyth County Chief Financial Officer, if applicable, and approval as to form and legality by the Forsyth County Attorney.
