**COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:** Recommend Approval

### SUMMARY OF INFORMATION:

Each year, the adopted budget includes funds to cover prior year encumbrances. For FY 2017-2018, \$2,000,000 was budgeted in Non-Departmental to cover prior year encumbrances. For FY 2016-2017, actual outstanding encumbrances as of June 30, 2017 totaled \$3,269,085.61. Of the outstanding encumbrances, \$1,200,842 represents the contract with Old Salem for the Old Boys School Renovation project and \$150,000 represents the contract with Creative Corridors.

This Budget Ordinance Amendment appropriates \$1,269,085.61 of Fund Balance to cover these outstanding obligations.

Excluding the above-mentioned contracts, total prior year encumbrances would have been \$1,918,243.95 and the \$2,000,000 budgeted would have sufficiently covered these outstanding obligations.

**EXPLANATION:**

Each year, the adopted budget includes funds to cover prior year encumbrances. For FY 2017-2018, \$2,000,000 was budgeted in Non-Departmental to cover prior year encumbrances. For FY 2016-2017, actual outstanding encumbrances as of June 30, 2017 totaled \$3,269,085.61. Of the outstanding encumbrances, \$1,200,842 represents the contract with Old Salem for the Old Boys School Renovation project and \$150,000 represents the contract with Creative Corridors.
