Thank you for your voice mail on May 8, 2018 to my request for a property tax refund. You stated that the city did not have a provision for refunds and suggested we discuss with our closing attorney if provisions were made for this pre-payment (we did discuss this and no provisions were made) and to submit a request in writing.

Background:

1. December 29, 2017, we paid our 2017 property tax of \$15,891.75.
2. December 29, 2017 we prepaid our 2018 property tax in the amount of \$15,891.75 in anticipation of new tax laws that might provide a deduction for this tax.
3. April 10, 2018, our home was sold and at closing, the prorated property tax for 2017 was included in the closing statement.

Since we have sold the home and paid our taxes, we hereby request a refund be sent to us in the amount of \$15,891.75 and mailed to 2649 Club Park Dr. Winston-Salem, NC 27104.
