**WHEREAS** Vernell D. Brown, a taxpayer, has made demand in writing for a refund of taxes due to an error in the account number submitted by the taxpayer;

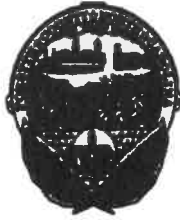
