**ORDINANCE NAMING A NEWLY CONSTRUCTED ROAD IN FORSYTH COUNTY,  
“WHITT STATION LANE”**

**WHEREAS**, Barbara Whitt requested a dedicated public road recently constructed by NCDOT, located within the unincorporated area of Forsyth County, be named Whitt Station Lane; and

**WHEREAS**, the Addressing/Street naming staff of the City/County Planning Department received a petition signed by two (2) of the three (3) adjoining property owners in support of the proposed road name; and

**WHEREAS**, the proposed road name does not pose any address range or road name duplication issues and has been reviewed and approved by emergency response agencies; and

**WHEREAS**, pursuant to the provisions of N.C.G.S 153A-239.1, at least ten (10) days prior to conducting the public hearing to name the said road, Forsyth County caused notice of the time, place, and subject matter of the hearing on this proposed road naming to be prominently posted at the Forsyth County Courthouse, and in at least two public places in the township where the road is located, and to be published in a newspaper of general circulation published in Forsyth County.

**NOW, THEREFORE, BE IT ORDAINED** by the Forsyth County Board of Commissioners, after providing notice and conducting a public hearing as required by law, that the new public road, as further identified on the attached map, is hereby named Whitt Station Lane.

**BE IT FURTHER ORDAINED** that after naming Whitt Station Lane, Forsyth County shall cause notice of this action to be given to the local Postmaster with jurisdiction over the said road, to the N.C. Board of Transportation, and to any municipality within five miles of the said road as required by law.

**BE IT FURTHER ORDAINED** that this Ordinance shall become effective upon its adoption.

This notice shall be published once at least ten (10) days before the public hearing date in a newspaper of general circulation in Forsyth County, and prominently posted at the County Courthouse and in at least two public places in the township or townships where the roads are located.

## Unnamed Streets to Macy Station Drive and Whitt Station Lane



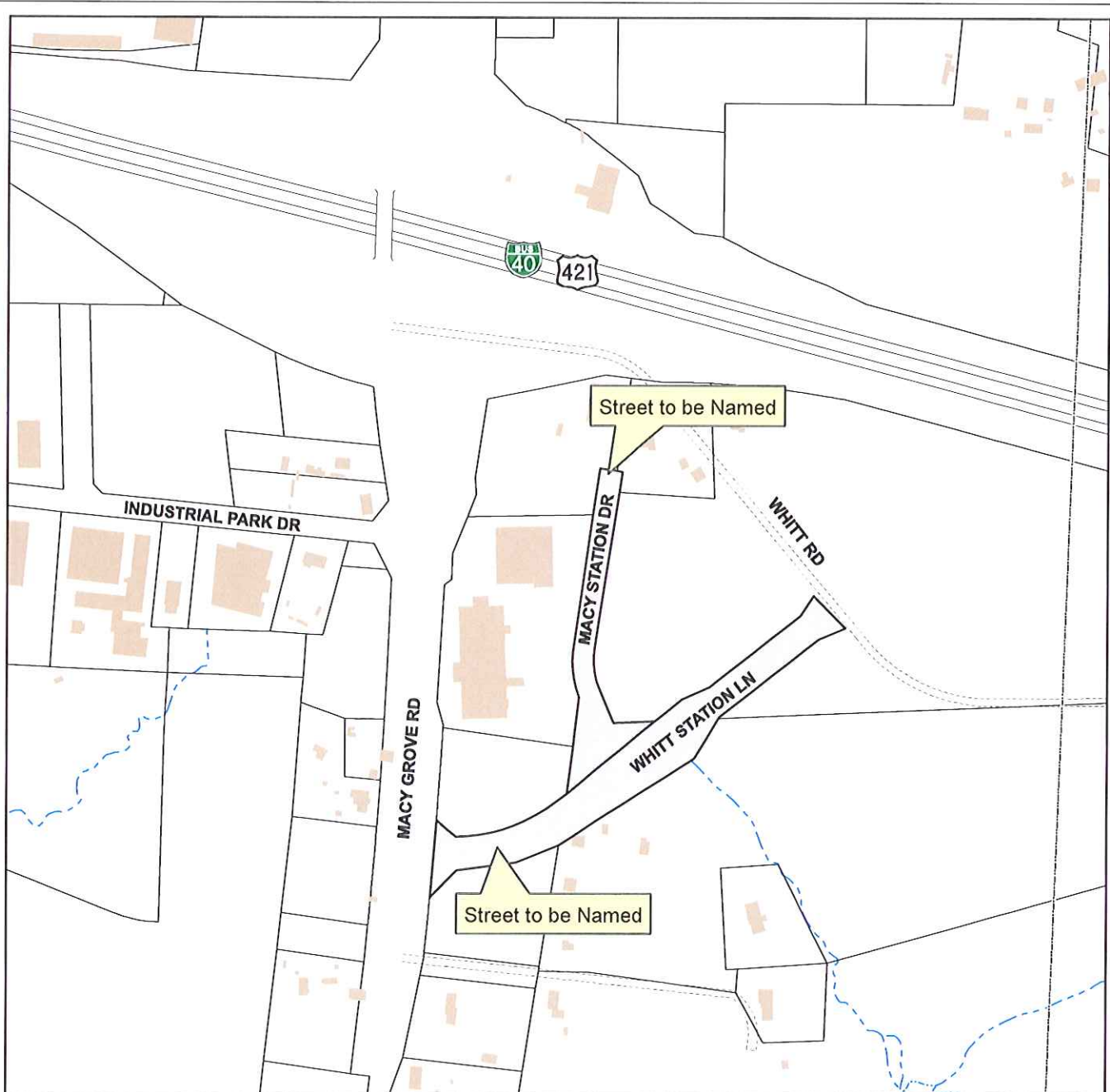

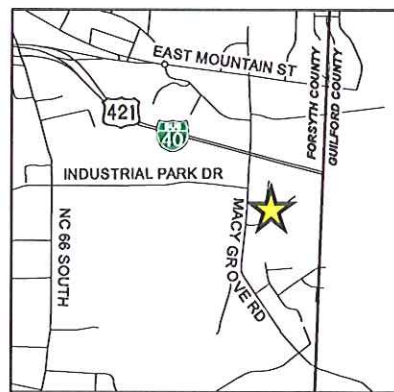




**Petition to Name**
