

**ORDINANCE NAMING A ROAD LOCATED WITHIN THE UNINCORPORATED
AREA OF FORSYTH COUNTY, "HORNEYTOWN COURT"
(MAPFORSYTH, CITY-COUNTY GEOGRAPHIC INFORMATION OFFICE)**

WHEREAS, MapForsyth, City-County Geographic Information Office staff requested a road located within the unincorporated area of Forsyth County be named, "Horneytown Court"; and

WHEREAS, the Addressing/Street naming staff of MapForsyth, City-County Geographic Information Office received no opposition to the proposed road name from the adjoining property owners; and

WHEREAS, the proposed road name does not pose any address range or road name duplication issues and has been reviewed and approved by emergency response agencies; and

WHEREAS, pursuant to the provisions of N.C.G.S. 153A-239.1, at least ten (10) days prior to conducting the public hearing to name the said road, Forsyth County caused notice of the time, place, and subject matter of the hearing on this proposed road naming to be prominently posted at the Forsyth County Courthouse and in at least two public places in the township where the road is located, and to be published in a newspaper of general circulation published in Forsyth County.

NOW, THEREFORE, BE IT ORDAINED by the Forsyth County Board of Commissioners, after providing notice and conducting a public hearing as required by law, that the road located within the unincorporated area of Forsyth County, as further identified on the attached map, is hereby named "Horneytown Court".

BE IT FURTHER ORDAINED that after naming "Horneytown Court", Forsyth County shall cause notice of this action to be given to the local Postmaster with jurisdiction over the said road, to the N.C. Board of Transportation, and to any municipality within five miles of the said road as required by law.

BE IT FURTHER ORDAINED that this Ordinance shall become effective upon its adoption.

This notice shall be published once at least ten (10) days before the public hearing date in a newspaper of general circulation in Forsyth County, and prominently posted at the County Courthouse and in at least two public places in the township nearest the road location.
